Lisa has been a member of the public health field for over 23 years and has served as director of the Office of Healthy Carolinians and Health Education at the North Carolina Division of Public Health; led the Public Health Incubator Collaboratives Program at the University of North Carolina (UNC) at Chapel Hill, and directed the Southeast Public Health Leadership Institute (SEPHLI) at UNC Gillings School of Global Public Health where she continues to stay connected as adjunct faculty in the Public Health Leadership Program. In 2015, Lisa served as the North Carolina Public Health Association president where she continues to stay involved connecting public health research and practice.

As a local health director in a rural district, Lisa enjoys advocating for rural public health and provides mentorship for students interested in public health and rural health.
